Re: Acevedo & Longfellow Potential Conflict of Interest Waiver from the Sleepy Hollow Fire Protection District for Representation of the Ross Valley Paramedic Authority, the Town of San Anselmo, the Marin Wildfire Prevention Authority, and the Muir Beach Community Services District

Dear Tom:

The purpose of this letter is to request a waiver from the Sleepy Hollow Fire Protection District (SHFPD) of potential conflict of interests in connection with our firm's representation of: 1) the Ross Valley Paramedic Authority (RVPA); 2) the Town of San Anselmo (Town); 3) the Marin Wildfire Prevention Authority (MWPA); and 4) the Muir Beach Community Services District (Muir Beach CSD).

Acevedo and Longfellow (A&L) serves as general counsel for the RVPA, the Town, the MWPA, and the Muir Beach CSD. We also represent the SHFPD.

The SHFPD is a member of RVPA, along with the Town. The SHFPD is also a member of the MWPA, together with the Town and the Muir Beach CSD.

In order for our firm to continue representation of the above-listed clients, the SHFPD must waive any potential conflicts of interests regarding the entities listed above. State Bar of California's Rule 1.7 requires informed consent of the client if there is a risk that representation of one client could be materially limited by an attorney's responsibility to another client. Here, there could be a potential conflict of interest in the future between one or more of the listed entities and the SHFPD.

There are no actual conflicts present at this time, and we do not anticipate any conflicts arising. The parties have productive working relationships among themselves, including the SHFPD. Should any actual conflict arise, A&L will withdraw from representation and help secure outside counsel.
